
I am in receipt of your letters of December 22, 24 and 28, 2015. I will attempt to answer the questions raised by you in these letters.

At the time the Board considers the Recommended Decision, it will also have before it the Respondent's Specific Objections to the Recommended Decision, the Petitioner's Objections to the Recommended Decision with attachments, Respondent's Response to Petitioner's Objections to the Recommended Decision and Petitioner's Response to Respondent's Response. Aside from Board Counsel's Board Memorandum which is protected by attorney-client privilege and work product from disclosure, the Board will have no other documents before it as the Board can only consider documents which are part of the record in this matter. Your correspondence to the Board members is not part of the record and will not be given to the Board Members.
